## SUMMARY ANNUAL REPORT FOR EMPLOYMENT PARTNERS BENEFITS FUND

This is a summary of the annual report of the Employment Partners Benefits Fund (Employer Identification Number 25-1000614, Plan Number 501) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Insurance Information**

The plan has insurance contracts with Vision Benefits of America and Metropolitan Life Insurance Company to pay certain vision, life insurance and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$736,939.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$353,506 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$333,133.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$79,612,956 as of the end of plan year, compared to \$81,674,937 as of the beginning of the plan year. During the plan year the plan experienced a decrease in its net assets of \$2,061,981. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$65,687,148 including employer contributions of \$57,835,226, employee contributions of \$171,267, gains of \$1,275,115 from the sale of assets, and earnings from investments of \$6,135,347. Plan expenses were \$67,749,129. These expenses included \$2,896,545 in administrative expenses, and \$64,852,584 in benefits paid to participants and beneficiaries.
